Instructions on completing the application form

- Please complete each part in full clearly and accurately. Incomplete application forms will not be processed.

- Non-local applicants Non-local students are defined as persons entering Hong Kong for purpose of education with a student visa or entry 4. permit issued by the Immigration Department of the HKSAR Government. Submission of applications

- The closing date for application is 30 January 2013.
- Completed application forms should be submitted to the School at the address below by hand or by post before the closing date for applications together with a crossed cheque or bank draft payable to "The Hong Kong Polytechnic University" for the required course fee. (Please write your name and the course code at the back of the cheque or bank draft.)

Notification of application results

- Normally successful applicants will receive a written notification from the School confirming their enrolment before course commencement.
- 8. Unsuccessful applicants will be notified in writing by the School. Course fees will be returned to them by ordinary mail.
- Please contact the School if you do not receive any notification one week before course commencement.

Refund policy

Except for unsuccessful applications or course cancellation, course fees paid are not refundable. Fees paid and places allocated on courses are not transferable.

Certification

- Certificates of Attainment will be issued to students who have attended 70% or above of the classes and passed the assessment. Eligible students will receive certificates by ordinary mail.
- 12. No certificate will be re-issued. If you need additional certification that you have completed the course, you may apply in writing and pay a fee of HK\$100*.

Use of information

- Personal data provided as part of an application for admission will, during the admission process, be used solely for the purpose of admission, and in this connection the data will be handled by SPEED and other relevant institutions authorised to receive it.
- Application documents of unsuccessful candidates will be destroyed after the admission process has been completed.
- Application documents of successful candidates will become part of the student file and the data will thereafter be handled by SPEED and 15. other relevant institutions authorised to receive it.
