

The Hong Kong Polytechnic University

Programme Features

The Preparatory Programmes for LLB and Diploma in Law described in this brochure prepare students for the examinations leading to the awards by the University of London.

PolyU SPEED is one of the only two institutions in Hong Kong that have Diploma teaching status for the Diploma in Law programme.

Full Learning and Teaching Support

The Preparatory Programmes are taught by full-time faculty from Advance Tertiary College (ATC), Malaysia and ITC School of Laws (ITC), Singapore. Both ATC and ITC have proven track records of producing graduates with excellent academic results. Each course consists of at least 60 hours of lectures and 20 hours of intensive revision. Mock examinations will be conducted in December and March. Students will be provided with a set of comprehensive lecture notes for each chapter in every course on which they have enrolled. Apart from face-to-face teaching, students will also have access to ATC and ITC online facilities, Teaching Mentor Student Assistance System as well as the University of London International Programmes study materials and Virtual Learning Environment (VLE). Guest lectures by academics from the University of London for selective courses may be arranged.

Diploma in Law students will have an additional 6 hours of English and legal research training.

Preparatory Programme for **DIPLOMA IN LAW**

Introduction

The Diploma in Law programme provides an opportunity for students who:

- satisfy the normal entrance requirements for the LLB degree to reach first year undergraduate level but without committing to a full degree; or
- intend to take the LLB degree but would like to gain a recognised intermediate award; or
- may not have had the chance to meet these requirements but can demonstrate that they have the ability, motivation and maturity to study at this level.

Duration

Part-time - 1 to 2 years

Tuition Fee

Tuition fee includes the cost of lectures, intensive revision workshops, special guest lectures, seminar pack and revision planner.

Enrolment for 4 courses: **HK\$31,200**

Enrolment for 2 courses: **HK\$17,600**

The above tuition fees exclude payments to the University of London and Hong Kong Examinations and Assessment Authority.

Programme Structure

The Preparatory Programme consists of 4 compulsory courses. Students may choose to enrol in all 4 courses on the same occasion, or by 2 stages, each consisting of 2 courses.

- **Public Law**

Entry Requirements

Applicants must be aged 18 or above before 1 September in the year of registration and have a good command of English.

All applicants are required to attend an admission interview and also to sit for a written test. Selection for admission will be entirely at the discretion of PolyU SPEED based on the guidelines laid down by the University of London.

Attendance Requirements

Students are required to attend a full-time or part-time course of instruction at an institution that is permitted to teach for this purpose. Students must comply with the attendance requirements of the institution. The University of London may refuse permission to sit an examination to a student who has not satisfied these requirements.

Examinations

The Diploma in Law examinations are usually held in May/June each year. Students need to apply for entry to the examinations. Application for entry to the examinations can be made through the Hong Kong Examinations and Assessment Authority.

The standard of the examination for the Diploma in Law is the same as that of the intermediate First Year examination of the LLB degree. Upon completion of the Diploma in Law, students may progress to the second year of the LLB Programme (Scheme A or B).

Introduction

Non-degree holders

Scheme A: This is a degree in its traditional format. It is divided into 3 parts. Students are required to complete a total of 12 courses, out of which 8 are compulsory courses. The minimum duration is 3 years with 4 courses taken each year.

Scheme B: This is intended for students who wish to study at a slower pace. It consists of 12 courses to be taken over 4 years.

Degree holders

Degree holders may apply for either **Graduate Entry Route A** (minimum 2 years) or **Graduate Entry Route B** (minimum 3 years). Students studying under Graduate Routes have to take 9 courses, out of which 7 are compulsory courses.

Each application will be considered on an individual basis and the decision taken at the discretion of the University of London.

Seats are limited and admission will be on a first-come, first-served basis.

Examinations

The LLB examinations are usually held in May/June each year. Students need to apply for entry to the examinations. Application for entry to the examinations can be made through the Hong Kong Examinations and Assessment Authority.


